CORONAVIRUS

We continue to have the full staff working in the office and maintenance however we are still trying to avoid contact and promoting social distancing. General Business

Our audits for LHA and Eastlawn East will be combined this year has been rescheduled for December 1 and 2. I am in the process of consolidating our banking accounts so that we have all accounts at one location.

Lex Development Corp

We are working toward the "sale" of the scattered site properties to the Lex Development Corp to complete the Section 18 Disposition portion of our efforts to remove a total of 81 units from public housing.

We are still pursuing the Section 18 Disposition to remove the Scattered Sites from Public Housing and then will complete the RAD Transaction to remove Eastlawn Apartments from Public Housing.
